**DECLARING ORDINANCE NO. 44, S-2024 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED “AN ORDINANCE ADOPTING THE PROVINCIAL ORDINANCE NO. 328-2024, “AN ORDINANCE INSTITUTIONALIZING THE ESTABLISHMENT AND OPERATIONALIZATION OF THE PROVINCEWIDE HEALTH SYSTEM, INCLUDING ITS MANAGEMENT SUPPORT SYSTEMS AND APPROPRIATING FUNDS THEREOF” OF THE SANGGUNIANG PANLALAWIGAN OF THE PROVINCE OF PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Municipal Ordinance No. 44, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 of R.A. No. 7160; Section 11, Article XIII of the 1987 Philippine Constitution; R.A. No. 11223 or the Universal Health Care Act of 2019;
