RESOLUTION NO. 253-2023

APPROVING RESOLUTION NO. 575, S-2022 OF THE SANGGUNANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 2 DULY INDORSED BY THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) THRU RESOLUTION NO. 004, SERIES OF 2022 AMOUNTING TO ELEVEN MILLION SIX-HUNDRED NINETY THOUSAND PESOS ONLY (P11,690,000.00)"

WHEREAS, the Sangguniang Bayan of Bayambang, Pangasinan submitted its SB Resolution No. 575, Series of 2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Bayambang, Pangasinan prepared the Supplemental Annual Investment Program No. 2 for CY 2022. This was endorsed by the Council, through MDC Resolution No. 004, Series of 2022 dated December 27, 2022, to the Sangguniang Bayan for approval;
2. The Supplemental AIP, which has a total investment requirement of P11,690,000.00, covers the augmentation of funds for Personal Services (granting of Service Recognition Incentives to permanent and casual employees) and Maintenance and Other Operating Expenses (granting of Gratuity Pay to Job-Order employees) of the LGU; and

3. Funding support for the LGU's Supplemental AIP is embodied in their Supplemental Budget No. 02, CY 2022 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 04, Series of 2022 dated December 29, 2022.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bayambang, Pangasinan;


