APPROVING RESOLUTION NO. 344, S-2024 OF THE SANGGUNANG OF MAPANDAN, PANGASINAN, ENTITLED "APPROVING THE 2024 AIP-SUPPLEMENTAL INVESTMENT PLAN (SIP) NUMBER 5 OF MAPANDAN, PANGASINAN AMOUNTING TO ONE MILLION NINE HUNDRED THIRTY FIVE THOUSAND ONE HUNDRED FORTY FIVE PESOS AND ELEVEN CENTAVOS (P1,935,145.11)"

WHEREAS, the Sangguniang Bayan of Mapandan, Pangasinan submitted its Resolution No. 344, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Mapandan, Pangasinan prepared their Supplemental Investment Program (SIP) No. 5 for CY 2024. This was endorsed by the Council, through MDC Resolution No. 06, Series of 2024 dated December 13, 2024, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
2. The Supplemental AIP which has total investment requirement of P1,935,145.11, covers the augmentation of funds for Maintenance and Other Operating Expenses (MOOE) and Capital Outlay (CO) of some offices of the LGU, and implementation of DRRM projects/activities and other priority projects of the municipality; and

3. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 5, FY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 6, Series of 2024 dated December 16, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mapandan, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 344, S-2024 of the Sangguniang Bayan of Mapandan, Pangasinan, entitled “Approving the 2024 AIP-Supplemental Investment Plan (SIP) Number 5 of Mapandan, Pangasinan amounting to One Million Nine Hundred Thirty Five Thousand One Hundred Forty Five Pesos and Eleven Centavos (P1,935,145.11)”;
