**RESOLUTION NO. 259-2023**

**DECLARING ORDINANCE NO. 02-2023 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED "AN ORDINANCE ON COLLECTION OF CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS RELATED TRANSACTIONS IN THE MUNICIPALITY OF ROSALES, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Rosales, Pangasinan submitted its Ordinance No. 02-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 129, 132 and 447 (3) (i) of R.A. 7160 and Section 11 (f) of R.A. No. 11032 "An Act Promoting Ease of Doing Business and Efficient Delivery of Government Services";

**WHEREAS**, subject ordinance shall take effect after the Sangguniang Bayan has complied with the legal requirements pursuant to Sections 187 and 188 of RA 7160;




