RESOLUTION NO. 259-2025

DECLARING MUNICIPAL ORDINANCE NO. 06-12262024 OF THE SANGGUNANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED “AN ORDINANCE REQUIRING INCREASED NIGHTTIME VISIBILITY AMONG MOTORCYCLE, TRICYCLE, BICYCLE, E-TRIKE AND E-BIKE RIDERS THROUGH THE USE OF HIGH-VISIBILITY REFLECTIVE VESTS OR LUMINOUSLY-COLORED GARMENTS FOR ALL MOTORCYCLE, AND TRICYCLE RIDERS AND REFLECTIVE VESTS, LUMINOUS-COLORED GARMENTS AND/OR HIGH-VISIBILITY LIGHTS FOR BICYCLE, E-BIKE AND E-TRIKE RIDERS WHILE TRAVELING ALONG THE THOROUGHFARES OF THE MUNICIPALITY OF POZORRUBIO, PANGASINAN FROM 6 P.M. TO 6 A.M. AND PROVIDING PENALTIES THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Municipal Ordinance No. 06-12262024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 16 & 447 (a) (1) (iii) (3) (vi) of R.A. No. 7160; and Provincial Ordinance No. 325-2024 Re: The Use of high-visibility reflective vests or luminously-colored garments for all motorcycle, bicycle, e-bicycle and tricycle riders dated July 1, 2024;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 06-12262024 of the Sangguniang Bayan of Pozorrubio, Pangasinan, entitled “An Ordinance requiring increased nighttime visibility among motorcycle, tricycle, bicycle, e-trike and e-bike riders through the use of high-visibility reflective vests or luminously-colored garments for all motorcycle, and tricycle riders and reflective vests, luminous-colored garments and/or high-visibility lights for bicycle, e-bike and e-trike riders while traveling along the thoroughfares of the Municipality of Pozorrubio, Pangasinan from 6 P.M. to 6 A.M. and providing penalties thereof” as within the conferred powers of the Sangguniang Bayan to enact;
