RESOLUTION NO. 260-2025

DECLARING MUNICIPAL ORDINANCE NO. 09-12262024 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED "AN ORDINANCE PROVIDING A COMPREHENSIVE YOUTH WELFARE AND DEVELOPMENT CODE IN THE MUNICIPALITY OF POZORRUBIO, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Municipal Ordinance No. 09-12262024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 17 (a) (iv) of R.A. No. 7160; Section 2 of Republic Act No. 8044 also known as the "Youth in Nation-Building Act"; Sections 2 & 23 of Republic Act No. 10742 also known as the "Sangguniang Kabataan Reform Act of 2015";

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 09-12262024 of the Sangguniang Bayan of Pozorrubio, Pangasinan, entitled "An Ordinance providing a Comprehensive Youth Welfare and Development Code in the Municipality of Pozorrubio, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
