RESOLUTION NO. 261-2025

DECLARING MUNICIPAL ORDINANCE NO. 10-12262024 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED "AN ORDINANCE PROHIBITING ONLINE SEXUAL ABUSE AND EXPLOITATION OF CHILDREN (OSAEC) AND CHILD SEXUAL ABUSE OR EXPLOITATION MATERIALS INSTITUTIONALIZING **PROGRAMS** FOR (CSAEM), AND **FURTHER PREVENTION** AND **ERADICATION** ESTABLISHING A SUPPORTIVE ENVIRONMENT FOR CHILD **MUNICIPALITY** OF POZORRUBIO, THE **VICTIMS** IN PANGASINAN AND PROVIDING FUNDS AND PENALTIES THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Municipal Ordinance No. 10-12262024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 2 of the Republic Act No. 11930, or "Anti-Online Sexual Abuse or Exploitation of Children (OSAEC) and Anti-Child Sexual Abuse or Exploitation Materials (CSAEM) Act"; Section 2 (a) (b) (1) (2) of the Republic Act No. 9775, or "Anti-Child Pornography Act of 2009"; Section 2 of the Republic Act No. 7610, or "Special Protection of Children Against Abuse, Exploitation and Discrimination Act"; and Sections 16 and 17 (a) (iv) of R.A. No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;
