**APPROVING THE ACCREDITATION OF RIDERS ALYANSA NG PILIPINAS INCORPORATED AND PANGASINAN 3<sup>RD</sup> DISTRICT CREDIT COOPERATIVE IN THE PROVINCE PROVIDED UNDER THE LOCAL GOVERNMENT CODE OF 1991**

**WHEREAS**, Section 34 of the Local Government Code of 1991 (Book 1, Chapter 4) states that local government units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy;

**WHEREAS**, on June 15, 2022, the Department of the Interior and Local Government issued Memorandum Circular No. 2022-083 on the Guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies;

**WHEREAS**, the **RIDERS ALYANSA NG PILIPINAS INCORPORATED AND PANGASINAN 3<sup>RD</sup> DISTRICT CREDIT COOPERATIVE**, respectively, have signified their intention to be an accredited CSO in the Province of Pangasinan to pursue an active partnership with the Local Government Unit in the pursuit of local autonomy and nation building;


