**APPROVING RESOLUTION NO. 2025-07 OF THE SANGGUNANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “CONFIRMING/APPROVING IN TOTO THE PROPOSED CY 2025 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 01 OF THE CITY OF ALAMINOS, PANGASINAN AMOUNTING TO TWO HUNDRED NINETY-TWO MILLION PESOS (P292,000,000.00) REPEALING FOR THE PURPOSE SP RESOLUTION NO. 2024-78 ADOPTED ON 23 APRIL 2024”**

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Resolution No. 2025-07 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Alaminos City, Pangasinan had identified items in their Supplemental Annual Investment Program (SAIP) No. 01, Series of 2025. This was endorsed to the Sangguniang Panlungsod for approval on January 16, 2025 by the City Development Council Executive Committee through Resolution No. 2025-01, Series of 2025;
2. Said SIP covers the Lot Acquisition (Project Site) and the Construction of School Building which will be funded out from the LGU's loan proceeds from the Development Bank of the Philippines (DBP);

3. Funding support for the implementation of the same in the amount of PhP292,000,000.00 is embodied in their proposed Supplemental Budget No. 01 for Calendar Year 2025 which was enacted by their Sangguniang Panlungsod through Appropriation Ordinance No. 2025-01 on January 28, 2025 and approved by the City Mayor on January 30, 2025.


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the City Government of Alaminos, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—
