APPROVING RESOLUTION NO. 2022-055, SERIES OF 2022 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED “CONCURRING/APPROVING MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2022-03, SERIES OF 2022 ENTITLED “REPROGRAMMING OF THE REMAINING UNEXPENDED FUNDING FROM THE TWENTY PERCENT (20%) DEVELOPMENT FUND, CALENDAR YEAR 2021 AMOUNTING TO TWO MILLION THREE HUNDRED FIVE THOUSAND FIVE HUNDRED THIRTY EIGHT PESOS AND FIFTY FIVE CENTAVOS (P2,305,538.55) TO FINANCE THE IMPLEMENTATION OF OTHER HIGHLY PRIORITIZED DEVELOPMENT PROGRAMS, PROJECTS AND ACTIVITIES OF THE MUNICIPAL GOVERNMENT OF STA. BARBARA, PANGASINAN FOR CALENDAR YEAR 2022 AND ENDORSING IT TO THE SANGGUNIANG BAYAN FOR APPROVAL”

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its SB Resolution No. 2022-055 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer and the Local Finance Committee of the Province have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Sta. Barbara, Pangasinan endorsed to the Sangguniang Bayan, the reprogramming of the LGU's Unexpended 20% Development Fund from CY 2021 in the amount of PHP2,305,538.55. This was endorsed by the Council to the Sangguniang Bayan through MDC Resolution No. 2022-03, Series of 2022 dated September 6, 2022 for approval.
2. The reprogramming was proposed to finance the implementation of other highly prioritized development projects of the LGU.

WHEREAS, the said programs/projects shall be integrated in the Supplemental Investment Program endorsed by the MDC and approved by their Sanggunian;

WHEREAS, the Sangguniang Bayan shall enact a supplemental budget since the subject resolution involves the reversion of the unexpended balance and its corresponding re-appropriation to other items of expenditure.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sta. Barbara, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 2022-055, Series of 2022 of the Sangguniang Bayan of Sta. Barbara, Pangasinan, entitled “Concurring/Approving Municipal Development Council (MDC) Resolution No. 2022-03, Series of 2022 entitled “Reprogramming of the remaining unexpended funding from the Twenty Percent (20%) Development Fund, Calendar Year 2021 amounting to Two Million Three Hundred Five Thousand Five Hundred Thirty Eight Pesos and Fifty Five Centavos (P2,305,538.55) to finance the implementation of other highly prioritized development programs, projects and activities of the Municipal Government of Sta. Barbara, Pangasinan for Calendar Year 2022 and endorsing it to the Sangguniang Bayan for approval”;
