**APPROVING RESOLUTION NO. 2022-105, SERIES OF 2022 OF THE SANGGUNANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED “APPROVING THE MUNICIPAL DEVELOPMENT PLAN OF THE MUNICIPALITY OF STA. BARBARA, PANGASINAN, FUNDED BY TWENTY PERCENT (20%) ECONOMIC DEVELOPMENT FUND AMOUNTING TO FIFTY TWO MILLION ONE HUNDRED THIRTY EIGHT THOUSAND ONE HUNDRED EIGHTY THREE PESOS (P52,138,183.00) FOR CALENDAR YEAR 2023”**

**WHEREAS**, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its SB Resolution No. 2022-105 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Sta. Barbara, Pangasinan prepared the LGU's Municipal Development Plan funded by 20% development fund for CY 2023. This was endorsed by the Council, through MDC Resolution No. 2022-09, Series of 2022 dated October 13, 2022, to the Sangguniang Bayan for approval;

2. The development projects proposed to be funded by the 20% Development Fund, which amounts to P52,138,183.00, were based on the Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects), and were integrated in the Annual Investment Program for CY 2023 of the LGU Sta. Barbara, which was endorsed by the Municipal Development Council thru MDC Resolution No. 2022-10, Series of 2022 and approved by the Sangguniang Bayan thru SB Resolution No. 2022-106, Series of 2022.


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sta. Barbara Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—


**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 2022-105, Series of 2022 of the Sangguniang Bayan of Sta. Barbara, Pangasinan, entitled “Approving the Municipal Development Plan of the Municipality of Sta. Barbara, Pangasinan, funded by Twenty Percent (20%) Economic Development Fund amounting to Fifty Two Million One Hundred Thirty Eight Thousand One Hundred Eighty Three Pesos (P52,138,183.00) for Calendar Year 2023”;
