WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Annual Budget for Calendar Year 2023 involving total appropriations of P352,510,888.00, which was enacted on December 14, 2022 through Appropriation Ordinance No. 2022-009, Series of 2022;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

That the appropriations for the implementation of the Fourth Tranche compensation adjustments shall be subject to the provisions of Local Budget Circular (LBC) No. 149 dated January 10, 2023 re: Implementation of the Fourth Tranche of the Modified Salary Schedule for Local Government Personnel Pursuant to Republic Act (RA) No. 11466. Therefore, the salaries of the following employees should be adjusted:
