DECLARING MUNICIPAL ORDINANCE NO. 2022-01 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "AN ORDINANCE ENACTING THE MUNICIPALITY'S CODE ON HEALTH AND SANITATION AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Ordinance No. 2022-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 & 17 (a) (2) (iii) (vi) and 447 (1) (iii) (vi) (ii) (4) (ii) (5) (xiii) of R. A. 716; RA 8749 or Clean Air Act of 1999; RA 9003 or Solid Waste Management Act; RA 9275 or Clean Water Act and PD 856 or Sanitation Code of the Philippines;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirement of publication pursuant to Section 511 (a) of RA 7160;
