APPROVING RESOLUTION NO. 2022-053 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED “RESOLUTION CONCURRING/APPROVING MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2022-01, SERIES OF 2022 ENTITLED “ADOPTING THE REPROGRAMMING OF THE REMAINING UNEXPENDED BALANCE OF LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (LDRRMF) CALENDAR YEAR 2020 AMOUNTING TO P1,530.30. LDRRM FUND FROM CALENDAR YEAR 2021 IN THE SUM OF P864,344.55 AND THE REPROGRAMMING OF LDRRM FUND OF CALENDAR YEAR 2022 IN THE AMOUNT OF 5,084,126.03 TOTALLING TO FIVE MILLION NINE HUNDRED FIFTY THOUSAND PESOS AND EIGHTY EIGHT CENTAVOS (P5,950,000.88) TO FINANCE THE IMPLEMENTATION OF DISASTER RISK REDUCTION AND MANAGEMENT PRIORITY PROGRAMS /PROJECTS/ACTIVITIES AND ENDORSING IT TO THE SANGGUNIANG BAYAN FOR APPROVAL”

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its SB Resolution No. 2022-053 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Sta. Barbara, Pangasinan endorsed to the Sangguniang Bayan, for approval, the reprogramming of the Unexpended Balances of the LGU's LDRRM Fund for CYs 2020, 2021 and 2022. This was endorsed by the Council to the Sangguniang Bayan through MDC Resolution No. 2022-01, Series of 2022 dated September 6, 2022;
2. The LGU revised their LDRRM Plan (CY 2022), upon recommendation of the LDRRM Council through Resolution No. 2022-04, Series of 2022, to include the following projects to be funded from the Unexpended LDRRM Fund (CYs 2020 to 2022) amounting to PHP5,950,000.88, to wit:

-Procurement of one (1) unit Payloader	P3,500,000.00
-Procurement of one (1) Unit Rescue/Response Vehicle	<u>P2,450,000.88</u>
Total	P5,950,000.88

3. The aforementioned LDRRM projects conform with NDRRMC-DILG-DBM JMC No. 2013-1 dated March 25, 2013, particularly Section 5 (Utilization of the LDRRMF/Projects and Activities) and Section 6 (Policies and Procedures on the Utilization of the LDRRMF).

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sta. Barbara, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2022-053 of the Sangguniang Bayan of Sta. Barbara, Pangasinan, entitled “Resolution Concurring/Approving Municipal Development Council (MDC) Resolution No. 2022-01, Series of 2022 entitled “Adopting The Reprogramming of the Remaining Unexpended Balance of Local Disaster Risk Reduction and Management Fund (LDRRMF) Calendar Year 2020 Amounting to P1,530.30 LDRRM Fund from Calendar Year 2021 in the sum of P864,344.55 and the reprogramming of LDRRM Fund for Calendar Year 2022 in the amount of P5,084,126.03, totalling to Five Million Nine Hundred Fifty Thousand Pesos and Eighty Eight Centavos (P5,950,000.88) to Finance the Implementation of Disaster Risk Reduction and Management Priority Programs/Projects/Activities and Endorsing it to the Sangguniang Bayan for Approval”;




