**DECLARING ORDINANCE NO. 02-2022 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITION OF ONE (1) ADMINISTRATIVE ASSISTANT V (PRIVATE SECRETARY I) WITH SALARY GRADE 11/1 AND APPROPRIATING FUNDS THEREOF UNDER THE OFFICE OF THE MUNICIPAL VICE MAYOR AND SANGGUNIANG BAYAN OF THE MUNICIPALITY OF SAN JACINTO, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**
