DECLARING ORDINANCE NO. 02-2022 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITION OF ADMINISTRATIVE ONE (1) ASSISTANT V (PRIVATE SALARY SECRETARY D WITH GRADE 11/1 AND APPROPRIATING FUNDS THEREOF UNDER THE OFFICE OF THE MUNICIPAL VICE MAYOR AND SANGGUNIANG BAYAN OF THE MUNICIPALITY OF SAN JACINTO, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN **TO ENACT**
