**RESOLUTION NO. 311-2023**

**DECLARING MUNICIPAL RESOLUTION NO. 247, S-2022 OF THE SANGGUNANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED “APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 2 FOR CALENDAR YEAR 2022 OF THE LOCAL GOVERNMENT UNIT OF SAN NICOLAS, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its SB Resolution No. 247, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council Executive Committee of San Nicolas, Pangasinan has formulated and endorsed the municipality's Supplemental Investment Program No. 2 thru MDC ExeCom Resolution No. 02-S.2022 dated September 27, 2022 to the Sangguniang Bayan for approval. This is in pursuance to Sections 106, 109, 114 of the Local Government Code of 1991;
2. The Supplemental Investment Program No. 2 with an investment requirement amounting to Php1,103,507.82 covers fund augmentation for Personal Services (creation of positions in various offices in LGU San Nicolas); and

3. The Sangguniang Bayan enacted Supplemental Budget No. 1 through Appropriation Ordinance No. 01, Series of 2022 dated November 8, 2022 to support the full implementation of the Supplemental Investment Program No. 02 of the municipality.


