APPROVING MUNICIPAL RESOLUTION NO. 286, S-2022 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 05 FOR CALENDAR YEAR 2022 (CY 2022) OF THE LOCAL GOVERNMENT UNIT OF SAN NICOLAS, PANGASINAN"

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its SB Resolution No. 286, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council (Executive Committee) of San Nicolas, Pangasinan has identified items in their Supplemental Investment Program No. 5 for CY 2022. This was endorsed to the Sangguniang Bayan on December 23, 2022 through MDC Resolution No. 07, CY-2022;
- The SAIP No. 5 of the municipality covers fund augmentation for Personal Services (granting of Service Recognition Incentive (SRI) to the municipal government officials and employees of LGU San Nicolas) and Maintenance and Other Operating Expenses of LGU San Nicolas; and

3. Funding support for the proposed SAIP, with a total investment requirement of PhP1,890,000.00 is embodied in the municipality's Supplemental Budget No. 04, CY 2022, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 05, Series of 2022 on December 27, 2022.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Nicolas, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was–

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 286, S-2022 of the Sangguniang Bayan of San Nicolas, Pangasinan, entitled "Approving Supplemental Annual Investment Program No. 05 for Calendar Year 2022 of the Local Government Unit of San Nicolas, Pangasinan";
