RESOLUTION NO. 314-2023

DECLARING THE SUPPLEMENTAL BUDGET NO. 4 FOR CALENDAR YEAR 2022 OF SAN NICOLAS, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P1,890,000.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Supplemental Budget No. 4 for Calendar Year 2022 involving total appropriations of P1,890,000.00, which was enacted on December 27, 2022 through Appropriation Ordinance No. 5, Series of 2022;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- 1. That the grant of Service Recognition Incentive (SRI) to regular & casual employees for FY 2022 shall be subject to the provisions of Budget Circular No. 2022-4 dated December 20, 2022; and
- 3. That the reversion of savings from Personal Services shall be in accordance with the provisions of Section 336 of RA 7160 (Use of Appropriated Funds and Savings).
