RESOLUTION NO. 315-2023

DECLARING MUNICIPAL ORDINANCE NO. 108, S-2021 OF THE SANGGUNANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED “AN ORDINANCE HONORING AND GRANTING CASH INCENTIVES AND OTHER BENEFITS TO RESIDENTS OF SAN NICOLAS, PANGASINAN, REACHING THE AGE OF EIGHTY-ONE (81) AND ABOVE REGARDLESS OF THEIR SOCIAL STATUS AS PART OF THE MUNICIPALITY’S EFFORT TO SUPPORT THE ELDERLY” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Municipal Ordinance No. 108, Series of 2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Republic Act No. 9994, otherwise known as “Expanded Senior Citizens Act of 2010” and Section 447 (a) (1) (5) (xvi) of R. A. No. 7160;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirement of posting pursuant to Sections 59 (a) of R. A. No. 7160;


