RESOLUTION NO. 326-2023

APPROVING RESOLUTION NO. 2023-033 OF THE SANGGUNANG BAYAN OF SISON, PANGASINAN, ENTITLED "APPROVING THE 1ST SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP)-CY 2023 OF THE MUNICIPALITY OF SISON, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Sison, Pangasinan submitted its SB Resolution No. 2023-033, Series of 2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Sison, Pangasinan has identified items in their 1ST Supplemental Annual Investment Program CY 2023. This was endorsed to the Sangguniang Bayan for approval on February 6, 2023 by the Municipal Development Council thru MDC Resolution No. 01-2023 Series of 2023;
2. Said SAIP of the municipality covers fund augmentation for Maintenance and Other Operating Expenses and Capital Outlay of some municipal government offices, and implementation of various development projects and disaster risk reduction & management programs/projects/activities of the municipality;

3. Funding for this SAIP is supported by Supplemental Budget No.1 which was enacted by the Sangguniang Bayan through Appropriation Ordinance No. 01, Series of 2023 on February 13, 2023 and approved by the Municipal Mayor on April 17, 2023;
4. The identified development project to be funded by the 20% of NTA is based on the DILG-DOF-DBM Joint Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects); and
5. The identified programs/projects/activities funded out of the 5% Local Disaster Risk Reduction and Management Fund (Php413,427.00) of the municipality conforms with Section 21 of RA 10121 and NDRRMC-DBM and DILG Memo Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of Local Disaster Risk Reduction and Management Fund). However, for the programs/projects to be funded by 2018-2022 MDRRM Trust Fund (Php6,934,262.39), the LGU is advised to observe Item 6.5 of NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 of the Department of Interior and Local Government, to quote: Section 6.5. The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the local sanggunian and Local Chief Executive (LCE), upon recommendation of the LDRRMC in accordance with the approved LDRRMP.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sison, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 2023-033, Series of 2023 of the Sangguniang Bayan of Sison, Pangasinan, entitled “Approving the 1st Supplemental Annual Investment Program (AIP)-CY 2023 of the Municipality of Sison, Pangasinan”;




