**PROVINCIAL RESOLUTION NO. 328-2023**

**AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE POZORRUBIO MUNICIPAL HEALTH CENTER BIRTHING FACILITY FOR THE USE OF THE AMBULANCE OF THE URDANETA DISTRICT HOSPITAL FOR TRANSPORT AND REFERRAL OF EMERGENCY CASES**

**WHEREAS**, the provincial government is an active partner of the cities and municipalities in the promotion of its worthwhile plans and programs particularly in the protection of the health and well-being of the people;

**WHEREAS**, the Urdaneta District Hospital, one of the 14 hospitals operated by the Provincial Government of Pangasinan, caters to patients coming from the different municipalities and other areas from nearby localities of the 5th District of Pangasinan;

**WHEREAS**, the Pozorrubio Municipal Health Center Birthing Facility in the operation of its medical facility intends to seek the ambulance service of the Urdaneta District Hospital;

**WHEREAS**, the Pozorrubio Municipal Health Center Birthing Facility needs the services of the Urdaneta District Hospital to cater and respond immediately to the health necessities of the people especially in times of emergencies, subject however, to existing rules, regulations and policies in the use of ambulance;

**WHEREAS**, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III and the Pozorrubio Municipal Health Center Birthing Facility, represented by Mayor Kelvin T. Chan, Pozorrubio, Pangasinan;
