**PROVINCIAL RESOLUTION NO. 336-2023**

**REQUESTING FINANCIAL ASSISTANCE FROM THE  
PHILIPPINE AMUSEMENT AND GAMING CORPORATION  
(PAGCOR) FOR THE INSTALLATION OF MEDICAL GRADE  
OXYGEN GENERATOR PLANT AT THE LINGAYEN DISTRICT  
HOSPITAL**

**WHEREAS**, one of the primordial concerns of the Provincial Government of Pangasinan is to address health issues and provide medical service needs of people by upgrading medical and health care facilities and equipment;

**WHEREAS**, among the objectives of Health Care Delivery Modernization Act of 2010 is to modernize the health delivery system by adopting a comprehensive, consistent, and systematic approach to health issues and concerns to complement the state-of-the-art technology;

**WHEREAS**, Philippine Amusement and Gaming Corporation (PAGCOR) supports the promotion of key health-related programs of the government by providing financial assistance to state-run hospitals, local government units, non-government organizations, other government agencies and individual beneficiaries;

**WHEREAS**, the fourteen (14) government hospitals owned and operated by the Provincial Government of Pangasinan necessitate a sufficient and self-reliant delivery of medical oxygen to sustain health service operations, especially during calamities and health emergencies;

**WHEREAS**, the Provincial Government of Pangasinan envisions to have a self-sustaining oxygen plant to be installed at the Lingayen District Hospital in order to support other provincial hospitals' oxygen needs;




**WHEREAS**, the installation of medical oxygen generator plant requires additional funding, and that PAGCOR has designated budget for such endeavor;


**NOW, THEREFORE**, in view of the foregoing, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –


