PROVINCIAL RESOLUTION NO. 337-2023

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE MUNICIPAL AGRICULTURE OFFICE AND THE RECIPIENT FOR THE IMPLEMENTATION OF THE LIVESTOCK AND POULTRY PRODUCTION PROGRAM IN THE PROVINCE OF PANGASINAN

WHEREAS, livestock and poultry production are among the major components of the Medium-Term Agricultural Development Program of the Department of Agriculture to ensure sustainability and food security of meat;

WHEREAS, through the Program, the Province of Pangasinan can set out the government's policies in the agriculture sector in attaining equitable distribution of opportunities, income-generating, expanding productivity, and sustaining increase in production of livestock and poultry thereby raising the quality of life of the people;

WHEREAS, the program gives foremost consideration to uplift the lives of the people of Pangasinan, especially those engaged in subsistence agriculture with equitable access to resources, income opportunities and support services;

WHEREAS, the Livestock and Poultry Production Program is embodied in various agreements on bull loan, buck loan, native pig production project, goat production, and free-range chicken production with the aim to strengthen rural economy;

WHEREAS, in the implementation and development of the program, the Provincial Government shall conduct capability building for effective and efficient management of the projects to be undertaken by the Province with the LGUs and their recipients;

WHEREAS, with an increased livestock and poultry production and an improved productivity, the Province and its people will be assured not only of their basic necessities but also of surplus products;

WHEREAS, there is a need for the Province through the Honorable Governor, Ramon V. Guico III, to enter into a Memorandum of Agreement with the LGUs and their recipients of the Program which is basically aimed towards food security and livelihood;


WHEREAS, Section 465 (vi) of RA 7160 provides that the Provincial Governor shall represent the Province in all its business transactions and signed in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREFORE, on motion of SP Member Nicholi Jan Louie Q. Sison, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement with the Municipal Agriculture Office and the recipient for the implementation of the Livestock and Poultry Production Program in the Province of Pangasinan;
