PROVINCIAL RESOLUTION NO. 338-2023

AUTHORIZING THE LAND BANK OF THE PHILIPPINES-LINGAYEN BRANCH TO REACTIVATE DORMANT ACCOUNTS OF THE PROVINCIAL GOVERNMENT OF PANGASINAN AND FURTHER AUTHORIZING THE PROVINCIAL GOVERNOR AND THE PROVINCIAL TREASURER TO EXECUTE AND SIGN ALL PERTINENT DOCUMENTS THEREOF

WHEREAS, the records of the Land Bank of the Philippines show that there are deposit accounts under the name of the Provincial Government of Pangasinan which have been inactive for almost a year and shall be reclassified as “Dormant” status;

WHEREAS, the Provincial Government of Pangasinan still needs to maintain the said accounts for its financial transactions;

WHEREAS, it is necessary therefore to reactivate two (2) account numbers under the following account names of the Province:

1. 2422-1049-60- PRDP Province of Pangasinan IREAP GOP; and
2. 2422-1049-79- PRDP Province of Pangasinan IREAP LGU Equity.

WHEREFORE, on motion of SP Member Vici M. Ventanilla, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as it is hereby authorized, the Land Bank of the Philippines-Lingayen Branch to reactivate dormant accounts of the Provincial Government of Pangasinan and further authorizing the Provincial Governor and the Provincial Treasurer to execute and sign all pertinent documents thereof;
