APPROVING MUNICIPAL RESOLUTION NO. 2022-069 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 3 FOR CALENDAR YEAR 2022 OF THE MUNICIPALITY OF LAOAC, PANGASINAN AMOUNTING TO ELEVEN MILLION ONE HUNDRED FORTY TWO THOUSAND THREE HUNDRED TWO PESOS & 09/100 (P11,142,302.09)”

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its SB Resolution No. 2022-069 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Laoac, Pangasinan had identified items in their Supplemental Annual Investment Program No. 3 for CY 2022, which was endorsed to the Sangguniang Bayan for approval on August 22, 2022 through MDC Resolution No. 2022-04;
2. The Supplemental Annual Investment Program No. 3, with an investment requirement amounting to Php11,142,302.09, covers the implementation of development projects of the municipality funded from realigned 20% Development Fund CYs 2021 & 2022;

3. Said SIP also includes the proposed programs/projects to be funded from the share of the LGU from Tobacco Excise Tax CYs 2011, 2013-2017, 2018 & 2019 consistent with Local Budget Memorandum Nos. 83 & 84 both dated November 22, 2021.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Laoac, Pangasinan;


