### RESOLUTION NO. 345-2023

**DECLARING MUNICIPAL ORDINANCE NO. 07-2022 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "AN ORDINANCE GRANTING FIVE HUNDRED PESOS (P500.00) AS BIRTHDAY CASH GIFT TO ALL REGISTERED SENIOR CITIZENS OF THE MUNICIPALITY OF ANDA, PANGASINAN AS A TOKEN OF APPRECIATION AND CARE AND APPROPRIATING FUNDS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Anda, Pangasinan submitted its Ordinance No. 07-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 17 (b) (2) (iv) and 447 (a) (5) (xvi) of R. A. 7160; Republic Act No. 9994, otherwise known as "Expanded Senior Citizens Act of 2010; Republic Act No. 10868 otherwise known as "An Act Honoring and Granting Additional Benefits and Privileges to Filipino Centenarians and for Other Purpose" and Article XV, Section 4 of the Philippine Constitution;
