**DECLARING MUNICIPAL ORDINANCE NO. 1, S-2022 OF THE SANGGUNIANG BAYAN OF MAPANDAN, PANGASINAN, ENTITLED “AN ORDINANCE ABOLISHING THE POSITION OF MUNICIPAL GOVERNMENT ASSISTANT DEPARTMENT HEAD I (SG-22) UNDER THE MUNICIPAL TREASURY OFFICE AND CREATING OF THE PLANTILLA POSITIONS UNDER THE FOLLOWING EXECUTIVE OFFICES IN THE MUNICIPALITY OF MAPANDAN, PROVINCE OF PANGASINAN: 1. MAYOR’S OFFICE, 2. LDRRM OFFICE, 3. MUNICIPAL HEALTH OFFICE, 4. MSWD OFFICE, AND 5. MUNICIPAL TREASURY OFFICE” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**
