**RESOLUTION NO. 37-2023**

**APPROVING MUNICIPAL RESOLUTION NO. 112-2022 OF THE SANGGUNIANG BAYAN OF NATIVIDAD, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) OF THE MUNICIPALITY OF NATIVIDAD, PROVINCE OF PANGASINAN FOR CY 2022"**

**WHEREAS**, the Sangguniang Bayan of Natividad, Pangasinan submitted its SB Resolution No. 112-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Natividad, Pangasinan had identified items in their Supplemental Annual Investment Program (SIP) for CY 2022. This was endorsed to the Sangguniang Bayan for approval on November 17, 2022 by the Municipal Development Council Executive Committee through Resolution No. 03-2022;
2. The SIP of the municipality covers fund augmentation for Personal Services (granting of Anniversary Bonus to municipal officials and employees), Maintenance and Other Operating Expenses, Capital Outlay of some municipal government offices of LGU Natividad and implementation of Local Tourism and Community Development Projects of the municipality; and

3. Funding support for the implementation of the same in the amount of PhP32,107,022.97 is embodied in their proposed Supplemental Budget No.1 for Calendar Year 2022 which was enacted by their Sangguniang through Appropriation Ordinance No. 04-2022 on November 29, 2022.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Natividad, Pangasinan;


