DECLARING MUNICIPAL ORDINANCE NO. 03-2022 OF THE SANGGUNIANG BAYAN OF DASOL, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE FOLLOWING POSITIONS: FOR THE REGULAR BUDGET: SANITATION INSPECTOR IV – RHU, SG-13; ADMINISTRATIVE ASSISTANT II (CLERK IV) – LCRO, SG-8; ADMINISTRATIVE ASSISTANT II (BUDGETING ASSISTANT) – BUDGET OFFICE, SG-8; ADMINISTRATIVE ASSISTANT I – ACCOUNTING OFFICE, SG-7; FOR DEVOLVED FUNCTIONS AND SERVICES: LICENSING OFFICER III – BPLO, SG-18; LOCAL DISASTER RISK REDUCTION AND MANAGEMENT ASSISTANT I – LDRRM OFFICE, SG-8; ADMINISTRATIVE ASSISTANT III (COMPUTER OPERATOR II) – TREASURY OFFICE, SG-9; ADMINISTRATIVE ASSISTANT III (COMPUTER OPERATOR II) – ASSESSOR’S OFFICE, SG-9; ADMINISTRATIVE ASSISTANT III (COMPUTER OPERATOR II) – RHU, SG-9; SOCIAL WELFARE OFFICER I – DSWD, SG-11; SOCIAL WELFARE AIDE – DSWD, SG-4; AND SENIOR ENVIRONMENTAL MANAGEMENT SPECIALIST – MENRO, SG-18” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 03-2022 of the Sangguniang Bayan of Dasol, Pangasinan, entitled “An Ordinance Creating the Following Positions: for the Regular Budget: Sanitation Inspector IV – RHU, SG-13; Administrative Assistant II (Clerk IV) – LCRO, SG-8; Administrative Assistant II (Budgeting Assistant) – Budget Office, SG-8; Administrative Assistant I – Accounting Office, SG-7; for Devolved Functions and Services: Licensing Officer III – BPLO, SG-18; Local Disaster Risk Reduction And Management Assistant I – LDRRM Office, SG-8; Administrative Assistant III (Computer Operator II) – Treasury Office, SG-9; Administrative Assistant III (Computer Operator II) – Assessor’s Office, SG-9; Administrative Assistant III (Computer Operator II) – RHU, SG-9; Social Welfare Officer I – DSWD, SG-11; Social Welfare Aide – DSWD, SG-4; and Senior Environmental Management Specialist – MENRO, SG-18” as within the conferred powers of the Sangguniang Bayan to enact;
