A. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 03-2022 of the Sangguniang Bayan of Dasol, Pangasinan, entitled "An Ordinance Creating the Following Positions: for the Regular Budget: Sanitation Inspector IV – RHU, SG-13; Administrative Assistant II (Clerk IV) – LCRO, SG-8; Administrative Assistant II (Budgeting Assistant) – Budget Office, SG-8; Administrative Assistant I – Accounting Office, SG-7; for Devolved Functions and Services: Licensing Officer III – BPLO, SG-18; Local Disaster Risk Reduction And Management Assistant I – LDRRM Office, SG-9; Administrative Assistant III (Computer Operator II) – Treasury Office, SG-9; Administrative Assistant III (Computer Operator II) – Assessor's Office, SG-9; Administrative Assistant III (Computer Operator II) – RHU, SG-9; Social Welfare Officer I – DSWD, SG-11; Social Welfare Aide – DSWD, SG-4; and Senior Environmental Management Specialist – MENRO, SG-18" as within the conferred powers of the Sangguniang Bayan to enact;
