PROVINCIAL RESOLUTION NO. 390-2023

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE LOCAL GOVERNMENT UNIT OF BAYAMBANG AND THE BAYAMBANG DISTRICT HOSPITAL FOR THE ADOPTION OF A HEALTH REFERRAL SYSTEM ON AMBULANCE SERVICES

WHEREAS, the 1987 Constitution ensures the protection and promotion of the right of the people to health and guarantees the availability of essential health services to all the people at affordable cost through various plans and programs;

WHEREAS, through the Universal Health Care Act, Filipinos are guaranteed equitable access to quality and affordable health care goods and services regardless of socio-economic status;

WHEREAS, the Provincial Government of Pangasinan assumes the role of an active partner of the various local government units in the Province particularly in the protection and promotion of health and well-being of the people;

WHEREAS, the Bayambang District Hospital is one of the fourteen hospitals operated by the Provincial Government of Pangasinan that responds and provides services in accordance with their service capacity and capability;

WHEREAS, the Local Government Unit of Bayambang has manifested the need for the ambulance services of the Bayambang District Hospital and the latter has agreed to provide effective and efficient ambulance services when the ambulance being used by the Local Government Unit of Bayambang is not available, subject to the terms and conditions stipulated in the MOA;

NOW, THEREFORE, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –


