RESOLUTION NO. 393-2023

DECLARING ORDINANCE NO. 2023-08 OF THE SANGGUNANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE RENAMING THE ALAMINOS CITY TOURISM OFFICE TO ALAMINOS CITY TOURISM AND CULTURAL AFFAIRS OFFICE, AMENDING FOR THIS PURPOSE THE TITLE AND ALL AFFECTED SECTIONS/SUBSECTIONS OF CITY ORDINANCE NO. 2013-10, OTHERWISE KNOWN AS THE "ALAMINOS CITY TOURISM CODE OF 2013" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2023-08 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the power of the legislative body to enact and approve ordinances or resolution carries with it power to amend, revoke, modify or repeal the same;
