RESOLUTION NO. 394-2023

DECLARING MUNICIPAL ORDINANCE NO. 02, S-2023 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED “AN ORDINANCE WAIVING THE BUSINESS TAX, PERMIT FEE AND OTHER REGULATORY FEES IMPOSED UNDER THE MUNICIPAL REVENUE CODE OF BANI, PANGASINAN ON BUSINESS ESTABLISHMENTS AND VENDORS TOTALLY AND PARTIALLY AFFECTED BY THE FIRE INCIDENT OF THE BANI PUBLIC MARKET, THIS MUNICIPALITY” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its Municipal Ordinance No. 02, Series of 2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

A. 7160;


