RESOLUTION NO. 396-2023

DECLARING ORDINANCE NO. 01-2023 OF THE SANGGUNIAN BAYAN OF BURGOS, PANGASINAN, ENTITLED "AN ORDINANCE PROVIDING FOR THE SUSTAINABLE MANAGEMENT, DEVELOPMENT AND CONSERVATION OF BURGOS MUNICIPAL WATERS AND ITS COASTAL AND FISHERY RESOURCES HARMONIZING AND INTEGRATING ALL ORDINANCES PERTINENT THERETO, AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Burgos, Pangasinan submitted its Municipal Ordinance No. 01-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 132 and 447 (a) (3) and (i) of R. A. No. 7160, Republic Act No. 8550 otherwise known as "Philippine Fisheries Code of 1998", Section 16.1 of DA Administrative Order No. 3, Series of 1998, otherwise known as the Implementing Rules and Regulation of the Fisheries Code of 1998, Republic Act No. 10601 otherwise known as the "Agricultural and Fisheries Mechanization Law" and Joint Memorandum Circular No. 2018-02 of the Department of Agriculture and the Department of the Interior and Local Government;
