DECLARING 01-2023 OF ORDINANCE PANGASINAN, SANGGUNIANG BAYAN BURGOS, OF ENTITLED "AN ORDINANCE **PROVIDING** FOR DEVELOPMENT **SUSTAINABLE** MANAGEMENT, CONSERVATION OF BURGOS MUNICIPAL WATERS AND ITS COASTAL AND FISHERY RESOURCES HARMONIZING AND INTEGRATING ALL ORDINANCES PERTINENT THERETO, AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
