RESOLUTION NO. 399-2023

DECLARING ORDINANCE NO. 187, S-2022 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED “AN ORDINANCE REGULATING NEW RESIDENTIAL, COMMERCIAL AND INDUSTRIAL ESTABLISHMENTS FOR CONSTRUCTION TO INCLUDE PERIMETER DRAINAGES IN THE CONSTRUCTION OF THEIR BUILDINGS AND IMPOSING PENALTIES THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 187, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 901 (General), Chapter IX (Sanitation) of the Presidential Decree No. 1096 “Adopting a National Building Code of the Philippines (NBCP) Thereby Revising Republic Act Numbered Sixty-Five Forty-One (R.A No. 6541)” and Sections 16, 17 (a) (viii) (2) (vi) and 447 (a) (5) (vii) of R. A. No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Sections 59 (c) and 511 (a) of R. A. No. 7160;
