PROVINCIAL RESOLUTION NO. 4-2023

INVITING THE PROVINCIAL HEALTH OFFICER, PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICER, AND THE PROVINCIAL DIRECTOR OF THE PHILIPPINE NATIONAL POLICE, INCLUDING THE PROVINCIAL HOSPITAL ADMINISTRATOR, TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN DURING ITS JANUARY 23, 2023 REGULAR (PHYSICAL) SESSION TO UPDATE THE BODY ON THE STATUS OF THE PUBLIC HEALTH SYSTEM OF THE PROVINCE

WHEREAS, by March 2023, after exactly three years, the Province of Pangasinan and the whole country will be marking its first national lockdown due to COVID-19 pandemic;

WHEREAS, the Province of Pangasinan is now experiencing a continuous decline on the average number of COVID-19 cases for the last several months as compared to the current surge of COVID 19 cases in some countries brought by new variants of concern;

WHEREAS, Pangasinan remained at low risk but the rise in cases must be monitored and health authorities should continue to be vigilant and focus not only in times of looming outbreak of COVID-19 but also to more common and equally deadly infectious diseases;

WHEREAS, for the last six months, the new set of members of the 11th Sangguniang Panlalawigan has not heard from the Provincial Inter-Agency Task Force (IATF) on the status of the public health system of the Province and the Sanggunian would like to inquire on the use of its resources as it shifts its attention from the pandemic to the different immunization programs being conducted in Pangasinan;



WHEREFORE, in view of the foregoing, on motion of SP Member Jerry Agerico B. Rosario, duly seconded, it was –


