BARBARA, PANGASINAN, ENTITLED “AN ORDINANCE ABOLISHING THE POSITIONS OF ADMINISTRATIVE ASSISTANT III - SG-9, ADMINISTRATIVE ASSISTANT V (DATA CONTROLLER III) - SG-11, NUTRITION OFFICER I - SG-10 AND SENIOR ADMINISTRATIVE ASSISTANT III - SG-15 UNDER THE EXECUTIVE DEPARTMENT OF THE LOCAL GOVERNMENT UNIT (LGU) OF STA. BARBARA, PANGASINAN AND ADMINISTRATIVE ASSISTANT V (DATA CONTROLLER III) - SG-11 UNDER THE SANGGUNIANG BAYAN OFFICE OF STA.
