### RESOLUTION NO. 402-2023

**DECLARING MUNICIPAL ORDINANCE NO. 2022-10 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED “AN ORDINANCE OFFICIALLY DECLARING AND ADOPTING THE SONG “ABANTE MANGALDAN” AS THE OFFICIAL MUNICIPAL HYMN OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Municipal Ordinance No. 2022-10 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with the General Welfare Clause under Section 16 of R. A. 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Marinor B. de Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 2022-10 of the Sangguniang Bayan of Mangaldan, Pangasinan, entitled “An Ordinance officially declaring and adopting the song “Abante Mangaldan” as the Official Municipal Hymn of the Municipality of Mangaldan, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;
