### RESOLUTION NO. 403-2023

**DECLARING MUNICIPAL ORDINANCE NO. 2022-12 OF THE SANGGUNANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE MANGALDAN CULTURE AND ARTS COUNCIL” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Ordinance No. 2022-12 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Article XIV of the 1987 Philippine Constitution, Sections 16 and 447 (a) (5) (xvi) of R. A. 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Marinor B. de Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 2022-12 of the Sangguniang Bayan of Mangaldan, Pangasinan, entitled “An Ordinance creating the Mangaldan Culture and Arts Council” as within the conferred powers of the Sangguniang Bayan to enact;
