RESOLUTION NO. 404-2023

DECLARING MUNICIPAL ORDINANCE NO. 2022-03 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED “AN ORDINANCE REGULATING THE ESTABLISHMENT AND OPERATION OF BOARDING HOUSES AND DORMITORIES IN THE MUNICIPALITY OF BINALONAN, PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF, AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Municipal Ordinance No. 2022-03 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16, 447 (a) (iii) (3) (ii) (4) (iv) of R. A. No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R. A. No. 7160;
