### RESOLUTION NO. 405-2023

**APPROVING RESOLUTION NO. 2023-170 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 2, FOR THE CALENDAR YEAR 2023 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2023-170 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Balungao, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No. 02. This was endorsed to the Sangguniang Bayan for approval on February 16, 2023 by the Municipal Development Council thru Resolution No. 2023-02;
2. Said SAIP No.2 of the municipality with an investment requirement of Php21,753,364.00 covers the implementation of programs/projects to be funded from the municipality's FY 2020 shares from the Tobacco Excise Tax;

3. These identified projects, Provision of Financial Support to Tobacco Farmers and Rehabilitation of Farm to Market Roads, are consistent with Local Budget Memorandum No. 86 dated December 14, 2022 “Guidelines on the Release and Utilization of the Shares of Local Government Units (LGUs) from the FY 2020 Collections of Excise Taxes on locally manufactured Virginia-Type Cigarettes under Republic Act (RA) No 7171, and Burley and Native Tobacco Excise Taxes pursuant to RA No. 8240, as amended by RA No.10351, and as further amended by RA 11346, chargeable against the Allocations to Local Government Units (ALGU) under the FY 2022 General Appropriations Act (GAA), RA No. 11639”; and
4. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 01 for Calendar Year 2023 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 2023-01 on March 06, 2023.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Balungao, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2023-170 of the Sangguniang Bayan of Balungao, Pangasinan, entitled “Approving the Supplemental Annual Investment Program (SAIP) No. 2, for the Calendar Year 2023 of the Municipality of Balungao, Pangasinan”;
