**RESOLUTION NO. 42-2023**

**APPROVING MUNICIPAL RESOLUTION NO. 250, S-2022 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED “APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 3 FOR CALENDAR YEAR 2022 FOR THE REVERSION OF PROJECTS AND PROGRAMS OF THE LOCAL GOVERNMENT UNIT OF SAN NICOLAS, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its SB Resolution No. 250, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of San Nicolas, Pangasinan has formulated and endorsed the municipality's Supplemental Investment Program No. 3 through MDC ExeCom Resolution No. 06-S-2022 dated October 21, 2022 to the Sangguniang Bayan for approval. This is in pursuance to Sections 106, 109, 114 of the Local Government Code of 1991;
2. The Supplemental Investment Program No.3 with an investment requirement amounting to Php5,550,000.00 covers fund augmentation for Maintenance and Other Expenses (Food assistance for every household in the municipality); and

3. The Sangguniang Bayan enacted Supplemental Budget No. 2 through Appropriation Ordinance No. 03, Series of 2022 dated November 21, 2022 to support the full implementation of the Supplemental Investment Program No. 03 of the municipality.


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Nicolas, Pangasinan;


