RESOLUTION NO. 437-2023

DECLARING MUNICIPAL ORDINANCE NO. 20-2023 OF THE SANGGUNANG BAYAN OF ANDA, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITION OF COOPERATIVE DEVELOPMENT SPECIALIST II UNDER THE OFFICE OF THE MUNICIPAL AGRICULTURIST OF THE MUNICIPALITY OF ANDA, PANGASINAN THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Ordinance No. 20-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76 & 447 (a) (1) (viii) of R. A. 7160;

WHEREAS, the LGU should prepare a supplemental appropriation (Supplemental Budget) to fund the newly-created position to back up its legal existence;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—


