RESOLUTION NO. 441-2023

APPROVING RESOLUTION NO. 2023-055 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED "APPROVING THE CY 2023 ANNUAL INVESTMENT PROGRAM (AIP) OF SUAL, PANGASINAN AMOUNTING TO FOUR HUNDRED FIFTY MILLION TWO HUNDRED SIXTY-EIGHT THOUSAND SIX HUNDRED FORTY-ONE & 91/100 PESOS (P450,268,641.91)"

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its SB Resolution No. 2023-055 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. In pursuance to Sections 106, 109, and 114 of the Local Government Code of 1991, the Local Development Council of Sual, Pangasinan has formulated the municipality's Annual Investment Program for Calendar Year 2023, which was endorsed to the Sangguniang Bayan for approval through MDC Resolution No. 4, Series of 2022 dated August 11, 2022;
2. The AIP of the municipality is in accordance with the Budget Operations Manual (BOM) for LGUs, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series

of 2007 dated March 8, 2007 DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Sual, Pangasinan was formulated following the prescribed AIP Summary Form categorized into general public, social, economic, and other services. It likewise covers: (a) all the regular budgetary items for the operations of the different municipal offices broken down into PS, MOOE, and Capital Outlay; (b) the priority development programs/projects and those to be funded by the 20% development fund, and; (c) disaster risk reduction management programs/projects/activities of the municipality. It further includes the following: 1) Gender and Development Plan, Peace and Order Plan and Anti-Drug Abuse Council Action Plan, Local Nutrition Action Plan, Climate Change Action Plan, Annual Procurement Plan, Annual Cultural Development Plan, and Local Youth Development Plan, and; 2) list of programs/projects/activities for the Local Council for Protection of Children, Senior Citizens and Persons with Disabilities, PPAs to combat Acquired Immune Deficiency Syndrome;

3. The proposed AIP has a total investment requirement of Php 450,268,641.91 which will be funded from the municipality's proposed 2023 Annual Budget enacted through Appropriation Ordinance No. 01 on February 23, 2023 amounting to Php 422,000,000.00 and the remaining Php 28,268,641.91 will be funded under external sources (ER 1-94 and DBM/DILG Fund);
4. The development fund amounting to Php 32,363,457.00 which is allocated for development projects and debt servicing, is equivalent to 20% of the municipality's NTA amounting to Php 161,817,289.00 for CY 2023. This is in accordance with Section 287 of RA 7160;
5. The identified development programs/projects to be funded by the 20% of NTA are based on the DILG-DOF-DBM Joint Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects);
6. The Disaster Risk Reduction and Management programs, projects and activities in preparation for and to mitigate the impact of disasters to be funded by the 5% Local Disaster Risk Reduction and Management Fund of the municipality amounting to Php 21,100,000.00, conforms with Section 21 of RA 10121. The programs/projects/activities to be funded out of the 70% LDRRM Fund amounting to Php14,770,000.00 are based on NDRRMC-DBM and DILG Memo Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of Local Disaster

Risk Reduction and Management Fund). Further, the LDRRMFI Plan 2023 of the municipality was reviewed by the Office of Civil Defense (OCD) as per attached OCD Certification dated January 17, 2023;

7. The LGU has also identified programs/projects/activities responsive to climate change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015; and
8. The Gender and Development Plan of the municipality has been reviewed by the Department of the Interior and Local Government (DILG) and was found to be fully compliant in form and contents with the provisions of the Joint Memo Circular of 2016-01: Amendments to JMC 2013-01 re: Guidelines on Localization of the Magna Carta of Women as per attached Certificate of Review and Endorsement of the DILG dated June 15, 2022.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sual, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—


