DECLARING ORDINANCE NO. 02-2023 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED "AN ORDINANCE CREATING PLANTILLA POSITIONS: DISABILITY AFFAIRS ASSISTANT AND ADMINISTRATIVE AIDE II (MESSENGER) UNDER THE OFFICE OF THE MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT; **RADIOLOGIC TECHNOLOGIST I, ADMINISTRATIVE AIDE III** (DRIVER I) AND ADMINISTRATIVE AIDE I UNDER THE PRIMARY CARE FACILITY-INFIRMARY" AS WITHIN THE **CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**
