**DECLARING ORDINANCE NO. 05, S-2023 OF THE SANGGUNANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "AN ORDINANCE TRANSFERRING THE POSITION OF ADMINISTRATIVE AIDE I (UTILITY WORKER 1 WITH SALARY GRADE 1) FROM THE GENERAL SERVICE OFFICE TO THE OFFICE OF THE MUNICIPAL ADMINISTRATOR" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**
