RESOLUTION NO. 45-2023

DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2022 OF SAN NICOLAS, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P2,000,000.00 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2022 involving total appropriations of P2,000,000.00, which was enacted on November 21, 2022 through Appropriation Ordinance No. 4, Series of 2022;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following finding:

1. That the funding sources for the subject supplemental budget were determined in accordance to Section 321 of R.A. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993.
