DECLARING ORDINANCE S-2023 NO. 4, OF THE SANGGUNIANG BAYAN OF PANGASINAN, ASINGAN, **ENTITLED "AN ORDINANCE ABOLISHING TWO (2) VACANT** POSITIONS, UNDER THE MUNICIPAL ACCOUNTANT OFFICE, ACCOUNTANT 1 (SALARY GRADE 12), PLANTILLA ITEM NUMBER 1081-003 AND FROM THE OFFICE OF THE MAYOR, ENVIRONMENT MANAGEMENT SPECIALIST I (SALARY GRADE 11), PLANTILLA ITEM NUMBER 1011-011" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
